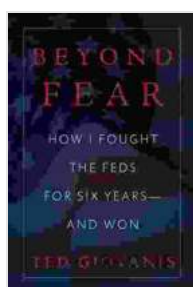

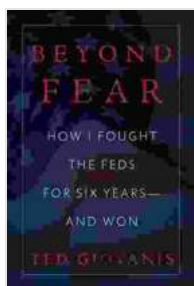
The Victory

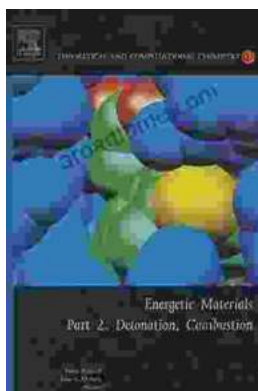
